A licensed plumbing contractor with at least 10 years experience, 5 which been in responsible charge of work;
A licensed electrical contractor with at least 10 years experience, 5 which been in responsible charge of work;
A licensed mechanical contractor with at least 10 years experience, 5 which been in responsible charge of work;
A citizens who is not an architect, engineer, plumbing contractor or electrical contractor, or a mechanical contractor and no ties to any building trade; and
